## **Craft Show & Marketplace**

#### **Vendor Expectations and Rules**

- 1. Setup begins at 8:30 am, and breakdown begins at 4:00 pm. The only exception to this is the weather.
- 2. Vendors are expected to stay throughout the show times.
- 3. All vendors must have their tents weighted, which prevents the tent from moving if there is a breeze or wind pick-up.
- 4. All Vendors must have their own tables, chairs, displays, etc., that may be required for booth setup.
- 5. All Vendors must be able to process transactions for sales in your booth. Alamo Craft Company is not responsible for processing sales payments for the craft show booths.
- 6. INSURANCE: The store shall not insure against the Vendor's inventory or personal items and shall not be liable for any losses to the person or property. The store shall carry general liability insurance for the building. However, deductions incurred due to losses attributable to the Vendor will be charged to the Vendor.
- 7. USAGE: The designated booth space may be occupied by the Vendor and used for the display and sale of quality crafts, collectibles, antiques, gifts, or jewelry. The Vendor may not use the premises for engaging in any unlawful activity or any acts or practices that create safety hazards or might damage the building or its contents.
- 8. ADVERTISING: The store reserves the right to use photographs or other images of the Craft Show, Vendor's merchandise, and booth displays in its advertisements.
- 9. INDENNIFICATION OF STORE AND STORES LANDLORD: Store and Store's Landlord shall not be responsible to Vendor for any damages to person or property caused by any act, omission, or neglect of Vendor or other Vendor or due to any other cause whatsoever, and Vendor agrees to indemnify Store and Store's Landlord free and harmless from all claims for any such damage. LEGAL COSTS: The vendor shall pay the store upon demand all attorney's fees, legal expenses, and court costs incurred by the store while enforcing any of the vendor's obligations under this agreement.
- 10. FOOD LICENSE: Any Vendor selling consumable items is required to have their Cottage License on hand. This is at the request of our friendly San Antonio Health Inspectors. Vendors may sell prepackaged food items prepared in a licensed commercial kitchen. Homemade food items are restricted from sale if the Vendor does not have a Cottage License on hand during the Craft Show. Food items will be labeled as required per the City Ordinance.
- 11. ALCOHOL: Alcohol products, including gift baskets, food/beverage items, and other such items, may not be sold in the store or craft show.
